#### **G. Outdoor Activities Coordinator:**

- February trip to Turrell: confirmed 28 scouts and 8 adults. The cabin only has capacity for 30. Another cabin is available but costs \$. Lean-tos are also available and one will be requested. The ranger suggested making a trip to Neversink recreation site but it requires a drive.
- Summer camp: Nobebosco (either Kit Carson or Paul Bunyon campsite) the early bird discount amount is \$ up to 4/15 and \$ afterwards. We will set our early bird due date as 3/31.

- Committee discussed the topic of moving our bank account to TD bank. Our account is in the name of the BSA, referencing a W9 with an EIN that we are unsure of who exactly it refers to. Further inquiries will be made to clarify who the EIN actually represents as well as discuss possibly moving to TD and retitling the account in the name of our Chartering Organization the American Legion.
